**Sub: Intimation of Road Assets offered by National Highways Authority of India ("NHAI") for potential acquisition by National Highways Infra Trust ("NHAI InvIT")**

**Ref: Our previous intimation vide letter dated 2<sup>nd</sup> September, 2022**

We refer to our previous intimation vide letter dated 2<sup>nd</sup> September, 2022 wherein we had informed that NHAI vide its letter dated 1<sup>st</sup> September, 2022, has identified the following five projects / Road Assets for potential acquisition by NHAI InvIT ("Round 3") under the Assets Monetization plan for FY 2022-23:

1. Gwalior Shivpuri (MP)
2. Vadodara Surat (Bridge across river Narmada)
3. Kota Bypass and Cable Stayed Bridge Across River Chambal on Kota Bypass approaches
4. Chennai Bypass
5. Rewa-Katni-Jabalpur-Lakhnadon (MP)

In this regard we wish to update that NHAI, vide its letter dated 9<sup>th</sup> November, 2022 has identified the following revised stretches to be taken for asset monetization under InvIT Bundle-3:

1. Gwalior Shivpuri (MP)
2. Chichira-Kharagpur (WB)
3. Orai-Bara (UP)
4. Kota Bypass and Cable Stayed Bridge across River Chambal on Kota Bypass approaches
5. Rewa-Katni-Jabalpur-Lakhnadon (MP)
6. Nalbari-Bijni-Guwahati
7. Guwahati Bypass-Nagaon-Daboka-Udauli
8. Rakhaldubi to Kohora
9. Nalbari-Bijni-Guwahati & Guwahati to Nagaon section including Guwahati Bypass
10. Bijni to West Bengal/ Assam Border

The same is subject to further evaluation and discussion by the Management and Board of Directors of National Highways Infra Investment Managers Private Limited ("NHIIMPL"), in its capacity as Investment Managers to NHAI InvIT.
