Sub. : Construction of Over/Under bridge at chainage 291/400 km. on NH-27 i.e. at crossing of Abu Nichlagarh road via Hanuman Tekari.

Respected sir,

This is to request your urgent intervention with regards to construction of Over bridge/ Under bridge utmost requirement on NH-27, Abu road, (Sirohi), Rajasthan.

As you may be aware, this highway is of critical importance as it offers vital connectivity towards Gujarat and a very popular Hill station, i.e. mount Abu. Though while construction of this highway NHA had provided a median opening for crossing of road and for crossing of animal at this chainage, but unfortunately this location became a Black Spot on NH-27. In last 5 years around 100 fatal accidents occurred and about 140 persons are lost.

This road through this junction point is a life line route of Bhakhar area road network in Aburoad Block. There are 8 Panchayat Headquarter & 26 villages of about 45,000 population located at different chainage on this road.

Presently all Commercial, Passengers and other slow driven vehicles as about 12,000 PCU are passing from the existing road crossing and approximate 8% growth rate has been assumed for every year.

In light of this I would be deeply grateful, if you could kindly consider this sensitive issue sympathetically and direct the sanctioning of an Over bridge/Under bridge to save the casualty on this spot.
